Effective: As from 27th January 2020 until withdrawal

The changes are marked *in italics* in the list of terms and conditions.

Changes effective as of 27th January 2020:

Announcement of pricing concerning safe deposit box rental agreements and safe custody service (provided under a separate agreement) concluded after the date of 3 December 2019.

The service can be used only and exclusively:

- at the Akadémia utca Branch (Budapest, V. ker. Akadémia u. 6.), until the branch is closed, and
- at the branch operating at Budapest, XIII. ker. Váci út 116-118., after the opening of the branch, during opening hours.

After the date of 03/12/2019, no new agreement can be concluded for safe deposit box service at the Akadémia utca Branch.

Until 29th February 2016 the title of the present List of Conditions was X. Other services.

1. Safe service (the "Safe Deposit Box Service")

After the branch is opened, the service can be used only and exclusively at the branch at Budapest, XIII. ker. Váci út 116-118., during opening hours.

² Indexation of charges and fees: The Bank links the calculation of the charges and fees indicated in the present List of Conditions to the average consumer price-index yearly announced by the Hungarian Central Statistical Office regarding the preceding calendar year. The amount or rate of such charges and fees shall be indexed each year from the 1st day of April automatically to the average consumer price-index applicable for the preceding calendar year. The indexed charges and fees shall be published each year in the present List of Conditions on or before the 1st day of April. Charges and fees shall be rounded off to the nearest whole HUF, or if determined in EUR to the nearest two decimal points, according to the general rules of rounding off. The Bank reserves the right not to apply indexation of charges and fees on one or more occasions regarding specific group of Clients or certain types of services.

³ Rental fee is payable for 6-month periods, in advance. Rental fee for the first 6 months is payable upon the conclusion of the safe deposit box rental agreement, and the rental fee concerning the next 6 months shall be due for payment on the 25th day of the last month of the last 6-month period for which fee has been settled. The amount of rental fees shall be debited automatically to the Lessee's Bank Account. In the event of the termination of the agreement, the time-proportional part of the prepaid rental fee shall be repaid to the Lessee.
